**LETTER OF INTENT**

The University of Messina – Italy (hereinafter “sending institution”) and the [Name of the Receiving Organisation] hereinafter “receiving organisation” agree to cooperate to promote mobility for traineeship of both students and postgraduates (hereinafter “Trainees”) within the framework of the ERASMUS+ - Key Action 1: Learning Mobility of Individuals, Activity – Student Mobility for Traineeships, for the realization of a training period abroad in an Enterprise/Institution or any other relevant workplace.

We hereby declare to cooperate with the University of Messina within the framework of the **ERASMUS+ - Key Action 1: Learning Mobility of Individuals, Activity – Student Mobility for Traineeships**, for the realization of a training period abroad in an enterprise or any other relevant workplace.

The project aims to support participants in the acquisition of competences, knowledge, skills and attitudes improving their personal development and career prospects, increasing their sense of initiative and entrepreneurship, as well as to enhance participants' foreign languages competences.

In order to establish a defined training plan for the trainees, the sending institution and the receiving institution agree to cooperate as follows:

**SENDING INSTITUTION**

The sending institution will:

- ~ select trainees on the basis of the academic merit and language skills;
- ~ make trainees aware of the importance to abide by rules and regulations of the receiving Organisation, to respect working hours, code of conduct and rules of confidentiality;
- ~ assign trainees EU grants swinging from € 430,00 to € 480,00 per month, up to the financial resources availability;
- ~ take out insurance policies to cover trainees against accidents and liability insurance;
- ~ specify the accident and liability insurance policies within the Learning Agreement for traineeship
- ~ evaluate the progress of the project on an on-going basis and take appropriate action if required together with the receiving Organisation;
- ~ evaluate the personal and professional development of the trainee;

**RECEIVING ORGANISATION**

The receiving Organisation will:

- ~ host the number of trainees specified in “Annex 1.A” per academic year;
- ~ require trainees to have the language skills specified in “Annex 1.A”;
- ~ accept trainees after the evaluation of their Learning agreements for traineeship, CVs and interview if needed;
- ~ sign trainees’ Learning Agreement for Traineeship before trainees departure;
- ~ involve trainees in activities that are relevant to their curricula;
- ~ arrange tutoring and ensure that appropriate equipment and support are available for trainees;
- ~ to assure that tasks and responsibilities for student trainees will be commensurate with their studies and professional qualification during the period;
- ~ evaluate the progress of the project on an on-going basis and take appropriate actions if required together with the sending institution;
- ~ interact with the sending institution for any queries that may arise;
- ~ sign all documents foreseen by the Programme at the end of the trainees’ stay;
- ~ fill in Annex 1.A (Trainees’ job description and trainees’ requirements) and Annex 1.B (information about receiving Organisation).

All the details mentioned above are mutually agreed. We agree not to contribute to each other financially.
