Cooperation agreement in the field of teaching, research and development

Between:

Helena Chodkowska University of Technology and Economics, with its registered office in Warsaw at Jutrzenki 135 Street, 02-231 Warsaw, entered in the Register of Non-Public Universities maintained by the Minister of Education and Science under number 5, having the number REGON: 015650551, NIP: 522-22-43-421, represented by the Rector - Prof. Iwona Przychocka, PHD,

And

University of Messina, with its registered office in Messina P.zza S. Pugliatti n1, 98122 Messina, Italy VAT number 00724160833 represented by the Rector - Prof. Salvatore Cuzzocrea

collectively, in the following part of the agreement, referred to as "Parties".

§ 1

1. The subject of the agreement is the cooperation between the Parties in the field of teaching, research and development.
2. The scope of cooperation referred to in Point 1, comprises in particular:
 - 1) enabling academic mobility of students, teachers, as well as non-academic staff of the University, to carry out specific periods of studies, internships, research and teaching visits in the host institution,
 - 2) mutual implementation of research and development works in the fields of science and scientific disciplines represented by the Parties,
 - 3) exchange of experiences leading to setting up new scientific, research and development projects,
 - 4) activities increasing the quality of education, for example by consulting study programs, mutual commissioning of teaching activities in a specific scope, as well as developing and implementing joint teaching projects between the Parties,
 - 5) participation in scientific initiatives (conferences, seminars, symposia, etc.) organized or co-organized by the Parties and mutual organisation of such initiatives,
 - 6) organizing and co-organizing training courses, namely the ones on methodology of teaching and improving the knowledge of foreign languages.

§ 2

1. The Parties undertake to cooperate with each other, taking into account their factual and legal capabilities.
2. Detailed rules of cooperation will be regulated in separate agreements to be concluded between the Parties.
3. The parties jointly declare that disputes related to the implementation of the provisions of this agreement will be resolved by mediation in the first place.

§ 3

1. The Parties undertake not to disclose confidential information received in connection with the implementation of this Agreement, except in cases provided for by law.
2. Each Party shall ensure that confidential information is properly secured and is communicated to its subordinate employees only in the manner and to the extent necessary for the proper performance of their duties.
3. The provisions contained in Points 1 and 2 do not prevent the Parties from disclosing information:
 - known to the Parties before the conclusion of the contract, without violating the law,
 - that is publicly known,
 - which has been disclosed in accordance with the legal requirements,
 - which is, in accordance with the Parties' arrangements and its nature, addressed to third parties in order to make them public, e.g. promotional and marketing information.

§ 4

1. The Parties agree to refer to the cooperation undertaken based on this Agreement and to disseminate information thereon.
2. The transfer of information referred to in Point 1 above, will be done, in particular, by
 - 1) placing information about the cooperation between the Parties on the official website: www.uth.edu.pl and www.unime.it, along with the logos and links to the Partner's websites and their contact details;
 - 2) mutual transfer and presentation of information materials about the Parties and their activities, in order to disseminate them among teachers, staff, as well as students of the University.

§ 5

2. The Parties are obliged to notify each other of changes to the data in Point 1 above. This change does not require the form of an annex to the Agreement.

§ 6

1. The present framework agreement shall be in force for a period of 5 years from the date of the last signature. Any amendment shall be made in written by the Parties. At the end of the period of 5 years the framework cooperation agreement may be renewed in written, unless 6 months before the expiry date one of the Parties notifies to the other Party the decision not to renew it. 2.
