2. The receiving institution will send its decision within **4 weeks** (I MESSINA01), **4 weeks** (PL JAROSLA02).
3. A Transcript of Records will be issued by the receiving institution no later than **5 weeks** (PL JAROSLA02) and (I MESSINA01) after the assessment period has finished at the receiving HEI.
4. Termination of the agreement

In the event of unilateral termination, a notice of at least one academic year should be given. This means that a unilateral decision to discontinue the exchanges notified to the other party by 1 September 20XX will only take effect as of 1 September 20XX+1.



